## GENERAL INFORMATION

This competition is recognized by both the USEF and the EVUSA. EVUSA rules will apply for all USEF and EVUSA classes offered. Please review the current EVUSA & USEF rule books. Rule books available at [www.usef.org](http://www.usef.org) and [www.equestrianvaulting.org](http://www.equestrianvaulting.org). **EVERY CLASS OFFERED HEREIN IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF AND EVUSA RULE BOOKS WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.**

### Registration

**Entries:** All entries must be submitted by midnight PST April 16th, 2025 via <https://horsesport.pro/>. For additional help using HorseSportPro for entries, review this [tutorial for entry managers](#).

**Payment:** Payments must be submitted on-line via <https://oakhillscomps.com/> by midnight April 16th, 2025.

**Waivers:** All required waivers MUST be signed and submitted electronically via <https://waiver.smartwaiver.com/v/OHC25/> by midnight April 16th, 2025. Each participant must complete the following forms including all required numbers and signatures.

- Federation Entry Agreement
- USEF Waiver & Release of Liability
- EVUSA Waiver & Release of Liability
- Oak Hills Stables Waiver & Release

**Post Entries:** No post entries will be allowed.

**Refunds:** In the case of injury to a participant or a horse before the start of the competition, refunds will be provided minus a \$5 processing fee, only if show management is notified of the scratch in writing before the competition starts, and appropriate medical documentation is provided. If a vaulter cannot compete due to COVID-19 restrictions, refunds will be issued, less the \$5 processing. No refunds will be provided for injuries sustained at the competition. Show management reserves the right to decide all issues related to potential refunds whether due to documented changes in entries or incorrect assessment of fees. All refunds will be processed after the close of the competition and provided to participating clubs if appropriate.

### Membership Requirements

**USEF Membership:** All vaulters, lungers, horses, horse owners, and coaches in USEF classes must be USEF members in good standing on the first day of competition, May 31st, 2025. To join or renew go to <https://www.usef.org/>

**EVUSA Membership:** All participating vaulters, lungers, horses and coaches must be AVA members in good standing by the first day of competition, May 31st, 2025. To join or renew go to: <https://inside.equestrianvaulting.org/>

**EVUSA Non-Member Fees:** Participants who choose to not become members by the close of entries, must pay the EVUSA non-member fee of \$25 and therefore be allowed to compete and earn ribbons. As a non EVUSA member, scores earned will not count for end of year awards.

**Composite Teams:** All composite teams must fill out the EVUSA composite team form and submit with their registration paperwork. No composite team will be allowed to compete without the appropriate form submitted. <https://equestrianvaulting.org/wp-content/uploads/2023/05/CompositRev.pdf>

### Competition Information

**Draw:** Draw for order of go will be done by computer by April 18th by the Show Manager and posted on HorseSport.pro <https://horsesport.pro/> by midnight PST on April 25th, 2025.

**Change Requests:** ALL requests for changes to entries or the Order of Go after close of entries MUST be received by Show Management in writing. Before the competition change requests can be made via email to [cambrykay@gmail.com](mailto:cambrykay@gmail.com). During the competition, changes must be made via filling out a request form in the office.

**Numbers:** Individual and Pas-de-Deux vaulters, and lungers, must wear their EVUSA number in accordance with current EVUSA and USEF rules. Horses must wear their EVUSA number on their bridle. Vaulters and lungers paying Non-member fees will be assigned a temporary number. Team members must wear numbers per EVUSA rules.

**Medal Testing:** Medal tests must be applied for directly through EVUSA 30 days prior to the event AND paid for through the competition. (2 separate payments & registrations: One to EVUSA per current rules and one to the competition through CompWeb via vaulter registration fees) Clubs or independents are responsible for applying for Medal Testing, at least 30 days before the competition, to the EVUSA, per the EVUSA Rulebook. **Coaches Check In:** All teams will be required to send one coach or team rep to the office to check-in on Friday May 30th from 9:00 a.m.- 5 p.m. and Saturday May 31st from 7:00 a.m.-8:00 a.m.. Check in must be completed prior to the club's first go. Please note that if a participating club has any questions and or concerns about the competition or the facilities, coaches may address their questions or concerns directly to the competition manager ONLY!

**Spectator Fees:** Due to limited parking and seating, a \$5 admission fee will be collected at the door for all spectators. Athletes, lungers and volunteers will have free admission to spectate the event all weekend.

**Volunteers:** All clubs must volunteer – sign ups can be done via a link at <https://horsesport.pro/>. Each vaulter is required to fill at least 1 job. Each Volunteer will receive free admission to the event in its entirety. Once a club has filled their volunteer spots a form will be sent to the coach to sign-up for vaulter practice times.

**Vaulter practice:** Arena practice times will be on Friday from 9:00 a.m.- 12:00 p.m. and potentially Friday later afternoon and evening based on the number of entries. Practice times will be set once job requirements are met by clubs and only when a medic is present. Fifteen minute increments will be allotted. Composite team/borrowed horses will get priority. There will be no mounted vaulting practice in the indoor arena unless the medic is present. **In the case that inclement weather affects the footing negatively, and/or the safety of the vaulter/horses due to the state of the footing, additional indoor arena practice times, as well as sufficient warmup times before each go will be made available.**

**Music:** In HorseSportPro, each club's music is self-service. The competition will play what it has received. The music deadline is midnight PST Friday May 16th, 2025. Only the Entry Manager for a club (the person who initially logged on to the system and who made the class entries) can upload music into HorseSportPro. Please see [this tutorial](#) on music uploading (also available at the [HorseSportPro Help Center Website](#)).

Any time after a club registers itself for Oak Hills Classic: music may be uploaded into a club "library" using the same login as was used for registration. On May 16th, 2025, the Music assignment ability CLOSES (Entry LOCK date). Please note when uploading music, explicit or inappropriate music will not be accepted by competition management and will be removed. Music needing to be uploaded or changed after the 5/16/2025 deadline will be subject to a \$25 late fee and require management's assistance.

**Order of Go:** EVUSA specifications for Order of Go (Standing Rules for Recognized Competitions) will be followed, with the exception that unrecognized classes may be "split" so that not all competitors go together, at the discretion of management.

**Gate times:** Please plan to attend all days. Gate times will be adhered to, with the exception of medical emergencies. Competitors are responsible for being at the appropriate gate at least 10 minutes before the assigned time. Keep an eye on the competition as classes may be running early. Any competitor not ready to enter the competition arena at the assigned time may be eliminated from the class. If there is a conflict between horse and barrel performance times, preference goes to the mounted class, but vaulters must make arrangements with the barrel arena gate steward.

Only those competitors on deck or warming up (as directed by the gate steward) are allowed in the warm up area and on-deck area. Competitors exiting the arena must yield to entering competitors and quickly clear the on-deck area. We appreciate everyone's help in keeping the competition area free of congestion.

**Buddy Horses:** must be held in a bridle and kept within the designated area.

**Awards:** Ribbons will be awarded up to 3rd place overall. There are separate divisions for Men and Women. High Point scores will be submitted for qualified events. Awards will be given to designated clubs at checkout to be distributed to the vaulters. No awards ceremony will take place.

## Horses and Facilities

**Health Requirements:** Horse must be in current standing with USEF health recommendations. This includes horses to be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables. It is not required to be turned in, however, a copy should be on hand if requested by USEF TD or Veterinarian. All horses will also need a USEF Horse Declaration Form filled out & turned into competition management which includes taking temperatures twice daily for the preceding 3 days prior to the event. See page 22.

Per Utah State requirements, all horses traveling from out of state require “a proof of ownership” document, a current copy of a negative Equine Infectious Anemia Test (coggins) and a Certificate of Veterinary Inspection (Health Cert.). Copies of Coggins & Health Certs will need to be provided to competition management. Additional health requirements may be needed, see biosecurity measures below.

During the show any horse with a temperature of 101.5 F or greater must be immediately reported as per USEF rule GR 873 to the competition management and veterinarian. Any horses with a temperature of 101.5 F or greater or any horse with clinical signs of an infectious disease may be required to move to isolation. Any horse deemed a potential infectious disease case by the veterinarian may be subject to diagnostic testing at owner expense.

**Biosecurity Measures:** In order to maintain a high level of biosecurity standards, horses attending this event will need to report a temperature recording 2x/day temp logs while on the premises. In the event the state of Utah or Utah County became VS-Affected, management will notify participants of additional USEF protocols required for horse entry personally via email to all horse owner/club managers registered. Additional protocols may include Veterinary VS Health Declaration prior to entry and Veterinary Inspection upon arrival. Show management also reserves the right to cancel the event due to VS outbreaks if need be.

**EVUSA Horse Award:** To be eligible for yearly EVUSA horse awards starting in 2023, an additional fee of \$20/annual registration or \$85/lifetime registration must be paid to the EVUSA by the start of the competition.

**Stabling:** Indoor stabling is 12x12 permanent stalls with included tack corner. Stalls have dirt flooring and sliding doors. Please bring your own horse's water buckets. Stabling is \$50 per night. Shavings will need to be hauled in or purchased from local Tractor Supply or IFA. Tack storage and feed storage areas are very limited and will be given to larger clubs (with multiple horses & vaulter) on a priority basis. Please plan to keep some tack, feed and supplies in trailers.

Horses may arrive **AFTER** 4 p.m. and **BEFORE** 8 p.m. Thursday evening – Sat **ONLY** (if you need to make arrangements for a different arrival or departure time please call or text Toree Glover, (801) 787-3902.

**PRIOR** to the competition so arrangements can be made with the facility). Additional nights will be



charged at the same daily rate of \$50 per stall. Stalls must be thoroughly cleaned prior to check out or a \$35 fine will be accessed.

### **Arenas:**

Competition Arena: Dimensions: 220' L x 90' W X 40' H - Footing: Sand and shavings mix.

Indoor Warm-up Circle: 1 @ 90' W x 80' L - Footing: Sand and shavings mix

Additional Riding/Lunging/Warm-up areas: 3 circles @ 60' W x 220' L - Footing: Dirt, Sand & Shavings mix.

**In the case that inclement weather affects the footing negatively, and/or the safety of the vaulter/horses due to the state of the footing, additional indoor arena practice times, as well as sufficient warmup times before each go will be made available.**

**Concessions:** Fire Artisan Flatbread Pizza Food Truck will be available onsite from 11:30 am -1:30 pm on Saturday. Gluten-free and vegan options will be available. Other food options are available within 5 miles of the facility.

**Dogs:** Dogs are **NOT** permitted on the premises.

**Directions to Oak Hills Stables:** From Spanish Fork Utah

- Start out going south on N Main St/UT-156 toward W 300 N. Continue to follow N Main St. (2.23 miles)
- N Main St becomes S State Rd/UT-198 (.26 mile)
- Turn left onto W Woodland Hills Dr. (2.86 miles)
- Turn left onto E Davis Dr (Portions unpaved). – Oak Hills Stable sign on your left



**Sharps Containers:** A minimum of one sharps container will be placed in the stall barn. Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments.

### CHEST WIDTH

Measured across the chest one inch below armhole when laid flat.

Start at center of neck and measure down shoulder, down sleeve to hem.

Measured from high point shoulder to finished hem at back.

## Additional Rules & Regulations

Management reserves the right to correct any error or make any changes in the schedule, program, Prize List, or class list at its discretion. The management accepts no responsibility for the decision of the judges.

All questions not covered in these rules and regulations shall be decided by the show management whose decision shall be final.

Every horse entered for competition will comply with the rules of the horse show management, but management will, in no case, be responsible for any loss or damage that may occur, and it shall be condition of entry that each exhibitor shall hold this horse show and the officials and employees of the show blameless for any loss or accident to his horse, employees, equipment, which may occur from sickness, fire or otherwise.

The management reserves the right to refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit entries and cancel award prizes without claims for damages; to cancel or combine unfilled classes, or to reschedule classes after due notice to exhibitors; to change rings or rotate judges.

Exhibitors are notified that any act of discourtesy or disobedience to the judges or officials, on the part of the owner, manager, rider, or groom shall disqualify the horse, and the owner shall forfeit his entry fee and other fees.

Show management reserves to itself the power to prohibit any person from attending or showing a horse in the ring and to remove any groom or horse from the show without being liable for compensation.

In accordance with the 1989 Federal Waste Tracking Act, which restricts the disposal of medical waste, bio hazardous medical waste containers will be provided in the stable area. All exhibitors and their agents are responsible for the proper disposal of this waste.

No person will be allowed in the show ring during the time of judging except the exhibitor and those having official or requested duties to perform.

It is the tradition of the show that riders be correctly attired for the class in question, that attendants be neatly dressed and the horses properly presented. Management may in its discretion bar any person from entering the ring if not suitably presented to appear before an audience.

### Motorized Vehicle Statement

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

### USEF Membership Statement

**Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes**
